1. Terms:

This includes, but is not limited to, claims for intentional acts, negligence, nuisance, noise, or any other legal claim that is cognizable in a state or federal court of law, regardless of whether related to my **PARTICIPATION** or **USE** of the property of **BRGA** during an event.
- c. **Limitations**: physical, mental, emotional or other limitations, disabilities, illnesses, injuries or conditions.
- 2. Agreement to Follow All Safety Rules and Directions: In consideration for me being permitted to participate and have use of the ranges of the Boyertown Rod and Gun Club (hereinafter "BRGA"), I, (Print Your Name) ________ (participant) hereby AGREE TO FOLLOW AND COMPLY WITH the written safety rules for the event(s) I am participating in, as well as all safety rules, range procedures, and directions, whether written or oral, of BRGA.
